COLLEGE COURSEWORK


Lott Leadership participants enroll in two college-level academic courses as part of the program:

Included in the program are opportunities to interact with college administrators, student leaders, and active community members while participating in current-event debates, discussions, and decision-making activities.

The program culminates in a carefully curated visit to Washington, D.C. On this trip, participants meet with their elected representatives, sample the cultural life of the nation's capital, and network with D.C. professionals working in both for-profit and non-profit worlds. Ideally, students completing the program will put their new skills to work for the betterment of their communities.

If accepted, students will enroll in two University of Mississippi courses and must attend all meetings. The trip to Washington, D.C., is a mandatory component of the program; students must fly to and from D.C. with the group. If a student is unable to commit to the program dates, he/she should decline nomination for consideration.

- Visits with federal officials, include U.S. Senators and Representatives
- Tours of capital city attractions

HOUSING

All students accepted to the program are housed with the Summer College for High School Students program in a residence hall designated specifically for them. Adult staff as well as counselors selected from the UM student body mentor and supervise. While in D.C., students will be closely supervised by University staff and student counselors. The group travels together and is housed in a secure setting.

COSTS

Once students are accepted to the program, they are required to pay a non-refundable \$100 registration fee to reserve their place in the program. Students are additionally responsible for a \$500 program fee at the start of the program, plus the cost of books, weekend meals, snacks, and souvenir/spending money. All remaining costs for room, board, tuition, and travel are covered by a program scholarship. Our website has information on fundraising resources and additional financial aid opportunities to help students defray their portion of the program costs.
